# An overview of the energy rebates

There are 6 NSW energy rebates on offer for low income households, families, seniors and people with certain medical conditions, and a crisis support scheme. The rebates include:

- Low Income Household Rebate (electricity)
- Gas Rebate
- Family Energy Rebate
- Seniors Energy Rebate
- Medical Energy Rebate
- Life Support Rebate.

Further energy cost assistance includes:

- Energy Accounts Payments Assistance scheme
- National Energy Bill Relief for the 2024-25 financial year.

Every year, almost one million households (around 1 in 3 households in NSW) access these programs to help pay their energy bills. On average, energy rebates help households reduce their electricity bills by 19.3% and their gas bills by 14.6%. ### National Energy Bill Relief

Copy and images to promote Nation Energy Bill Relief to your networks.

#### Email copy

All households in NSW are eligible for a National Energy Bill Relief payment of up to \$300 on their electricity bill this financial year.

Most households will receive their Bill Relief payment automatically from their electricity retailer in quarterly instalments on their electricity bill.

Households in an embedded network, such as an apartment building, residential park or retirement village, may need to apply for their Bill Relief payment.

# Energy rebate values, eligibility and applications

### Low Income Household Rebate

The value, eligibility requirements and application details for the Low Income Household Rebate.

Value in 2024-25 financial year	\$350
Utility	Electricity
Eligibility	You must:  • have an electricity account for your primary residential address in NSW  • be the account holder (the account and bill must be in your name)  • hold one of the following:  • Pensioner Concession Card issued by Services Australia or Department of Veterans' Affairs (DVA)  • Low Income Health Care Card  • Health Care Card issued by Services Australia, or  • Department of Veterans' Affairs Gold Card.
How to apply	<ul> <li>Retail (on-market) customers can contact their electricity retailer to apply the rebate to their account.</li> <li>Embedded network (on-supply) customers can apply online or via mail using the details on the <u>Service NSW website</u>.</li> </ul>

### **Gas Rebate**

The value, eligibility requirements and application details for the Gas Rebate.

Value in 2024-25 financial year	\$110
Utility	Natural gas, or bottled or metered liquefied petroleum gas (LPG)
Eligibility	You must:



	<ul> <li>have a natural gas or bottled LPG gas (more than 45 kg or 88 litres) account for your primary residential address in NSW</li> <li>be the account holder (the account and bill must be in your name)</li> <li>hold one of the following:</li> </ul>
	<ul> <li>Pensioner Concession Card issued by Services Australia or the Department of Veterans' Affairs (DVA)</li> <li>Low Income Health Care Card</li> <li>Health Care Card issued by Services Australia, or</li> <li>Department of Veterans' Affairs Gold Card.</li> </ul>
How to apply	<ul> <li>Retail (on-market) customers can contact their gas retailer to apply the rebate to their account.</li> <li>Embedded network (on-supply) and bottled LPG customers can apply online or via mail using the details on the <u>Service NSW website</u>.</li> </ul>

### Family Energy Rebate

The value, eligibility requirements and application details for the Family Energy Rebate.

Value in 2024-25 financial year	Up to \$250
Utility	Electricity
Eligibility	<ul> <li>You must:</li> <li>have an electricity account for your primary residential address in NSW</li> <li>be the account holder (the account and bill must be in your name)</li> <li>have received the Family Tax Benefit in the previous financial year and you have:</li> <li>lodged your tax return for the last financial year with the Australian Tax Office (ATO), and</li> <li>finalised your entitlement to the Family Tax Benefit payments with Centrelink.</li> </ul>
How to apply	Retail (on-market) customers can apply online on the <u>Service NSW</u> <u>website</u> .



•	Embedded network (on-supply) customers can apply via mail using the
	details on the <u>Service NSW website</u> .

### **Seniors Energy Rebate**

The value, eligibility requirements and application details for the Seniors Energy Rebate.

Value in 2024-25 financial year	\$250
Utility	Electricity
Eligibility	<ul> <li>You must:</li> <li>have an electricity account for your primary residential address in NSW</li> <li>be the account holder (the account and bill must be in your name)</li> <li>hold a Commonwealth Seniors Health Card issued by Services Australia or the Department of Veterans' Affairs.</li> </ul>
How to apply	You can apply in person at a Service NSW Centre or online on the <u>Service NSW website</u> .

## **Medical Energy Rebate**

The value, eligibility requirements and application details for the Medical Energy Rebate.

Value in 2024-25 financial year	\$350
Utility	Electricity
Eligibility	All the following must apply:  • you have an electricity account for your home in NSW  • you are the account holder (the account and bill must be in your name)  • you hold one of the following:  • Pensioner Concession Card issued by Services Australia or the Department of Veterans' Affairs (DVA)  • Low Income Health Care Card  • Health Care Card issued by Services Australia, or



	o DVA Veteran Gold Card
	you or someone living with you:
	o is not able to self-regulate body temperature
	<ul> <li>has been assessed by a registered medical practitioner (GP or specialist) who has been treating you or the person for at least 3 months, and</li> </ul>
	<ul> <li>meets at least one Primary Qualifying Condition and at least one Secondary Qualifying Condition.</li> </ul>
How to apply	Retail (on-market) customers can download the form on the <u>Service NSW</u> <u>website</u> and contact their electricity retailer to submit their form.
	Embedded network (on-supply) customers can apply in person at a     Service NSW Centre or apply online on the <u>Service NSW website</u> .

# **Life Support Rebate**

The value, eligibility requirements and application details for the Life Support Rebate.

Value in 2024-25 financial year	Up to \$1,638.70, depending on equipment type
Utility	Electricity
Eligibility	<ul> <li>All the following must apply:</li> <li>you have an electricity account for your primary residential address in NSW</li> <li>you are the account holder (the account and bill must be in your name)</li> <li>you or someone living with you has been assessed by a registered medical practitioner to verify that the use of the approved life support equipment is required at their principal place of residence.</li> </ul>
How to apply	<ul> <li>Retail (on-market) customers can download the form on the <u>Service NSW website</u> and contact their electricity retailer to submit their form.</li> <li>Embedded network (on-supply) customers can apply online or via mail using the details on the <u>Service NSW website</u>.</li> </ul>



### **Energy Accounts Payment Assistance (EAPA)**

The value, eligibility requirements and application details for EAPA.

Value in 2024-25 financial year	Up to \$2,000 (maximum of 2 applications for the maximum amount of \$500 for electricity and \$500 for natural gas)
Utility	Electricity and natural gas
Eligibility	<ul> <li>You must:</li> <li>have an electricity or natural gas account for your primary residential address in NSW</li> <li>be the account holder (the account and bill must be in your name)</li> <li>not have paid your most recent bill and the account is still open</li> <li>be experiencing a short-term financial hardship, crisis or emergency and unable to pay your most recent energy bill.</li> </ul>
How to apply	Apply online on the <u>Service NSW website</u> or apply in person or over the phone with an approved <u>non-government EAPA provider</u> .

## National Energy Bill Relief for households

The value, eligibility requirements and application details for National Energy Bill Relief for households.

Value in 2024-25 financial year	Up to \$300 for the 2024-25 financial year
Utility	Electricity
Eligibility	All households in NSW
How to apply	<ul> <li>Retail (on-market) customers will automatically receive Bill Relief payments from their electricity retailer in quarterly instalments of \$75 on their electricity bill from 31 July 2024, 1 October 2024, 1 January 2025 and 1 April 2025.</li> </ul>
	These customers do not need to apply and should contact their electricity retailer for all enquiries relating to Bill Relief delivery.
	Embedded network (on-supply) customers eligible for the Low Income Household Rebate, Family Energy Rebate, Medical Energy Rebate or Life



Support Rebate will receive Bill Relief payments automatically after receiving their rebate.
<ul> <li>Seniors Energy Rebate customers must apply for their Bill Relief payment at energy.nsw.gov.au/national-energy-bill-relief.</li> </ul>
<ul> <li>Most embedded network (on-supply) customers need to apply for their Bill Relief payment. Find out more at energy.nsw.gov.au/national-energy- bill-relief.</li> </ul>

# National Energy Bill Relief for small businesses

The value, eligibility requirements and application details for National Energy Bill Relief for small businesses.

Value in 2024-25 financial year	Up to \$325 for the 2024-25 financial year
Utility	Electricity
Eligibility	<ul> <li>Small businesses that:</li> <li>have an active Australian Business Number (ABN)</li> <li>are named on the electricity bill or account</li> <li>are on a separately metered business tariff</li> <li>have an annual electricity consumption below 100 MWh.</li> </ul>
How to apply	<ul> <li>Small businesses that are retail (on-market) customers will automatically receive Bill Relief payments from their electricity retailer in quarterly instalments of \$81.25 on their electricity bill from 31 July 2024, 1 October 2024, 1 January 2025 and 1 April 2025.</li> <li>These small businesses do not need to apply and should contact their electricity retailer for all enquiries relating to Bill Relief delivery.</li> <li>Most small businesses that are embedded network (on-supply) customers need to apply for their Bill Relief payment.
